ERIN'S LAW

Child sexual abuse is a pervasive societal problem. Nationwide, 1 in 4 girls and 1 in 6 boys are sexually abused before the age of 18. However, a recent report from The Ford Family Foundation, Protect Our Children and the University of Oregon's Center for Prevention of Abuse and Neglect found that nearly 1 in 3 Oregon and Siskiyou County children (29%) experience at least one form of child sexual abuse. The same study also showed that prevention education works! Adults who participated in Protect Our Children training compared with randomly selected Oregonians were five times more likely to report they know how to help prevent child abuse in their community, and nearly three times more likely to look for signs of sexual abuse in children.

In 2015, Oregon passed <u>SB 856</u> (Erin's Law), which requires administrators, teachers, other school personnel and students at K-12 public schools to receive child sexual abuse prevention training. In addition, the Oregon State Board of Education amended the human sexuality education administrative rule (<u>581-022-1440</u>) to require each school district board to "adopt a child sexual abuse prevention instructional program for students in kindergarten through grade 12."



SB 856 (Erin's Law) mandates that all Oregon public schools provide:

- A minimum of four (4) instructional sessions (equal to or greater than a standard class period) of sexual abuse prevention instruction per year for grades K-12.
- Sexual abuse instruction that is integrated and part of required district comprehensive sexuality education plan and is aligned with state standards.
- Instruction that is age appropriate, medically accurate, and is not shame or fear based.
- Instruction that is culturally inclusive and is responsive to diverse students including race, ethnicity, gender identity and sexual orientation.
- A parental involvement component to inform parents about child sexual abuse topics.
- A professional training component for administrators, teachers and other school personnel.


